Initial Research:

- 1. Where is Machu Picchu located? Provide a map. (3 marks)
- 2. Explain why Machu Picchu is referred to as the 'Lost City' of the Incas? (4 marks).
- 3. State the role of Machu Picchu in the time of the Inca Empire (2 marks).
- 4. Identify the features of the site of Machu Picchu that made it the ideal location for a secret city (3 marks).
- 5. Using images found on the internet, describe the landscape surrounding Machu Picchu and why this is significant (3 marks).
- 6. Discuss the advantages and disadvantages of living in such a location (4 marks).
- 7. Using a diagram of the site, describe the layout of Machu Picchu. Provide a topographic map of Machu Picchu. (3 marks)

Detailed Report:

Undertake your own research into the Inca Civilisation and present your findings as an illustrated extended report that includes the following information: (18 marks)

- History and Geographical Boundaries of the Inca Empire
- Population distribution
- Economy
- Social structure
- Religion
- Architecture
- Urban centers (including Cusco)
- The Inca civil war and the Spanish Conquest
- As a result of all this information, why this site is so important.
